

Independent Auditor's Review Report on the Unaudited Interim Financial Results

To

The Board of Directors of Indo Tech Transformers Limited

1. We have reviewed the accompanying Statement of Unaudited Financial Results of **Indo Tech Transformers Limited** ("the Company") for the quarter ended 30th June, 2023 ("the Statement").
